1. Pursuant to A.R.S. §38-847, a Regular Public Safety Personnel Retirement System Board meeting was convened on March 31, 2021 at the Maricopa County Sheriff's Office Headquarters, 550 West Jackson Street, 4th Floor – Conference Room 422, Phoenix, Arizona 85003.

2. Mr. Garcia called the meeting to order at 10:31 a.m., with a quorum of the membership in attendance.
3. A motion was made by Deputy Wisda and seconded by Mr. Blais to approve the Regular Board Meeting Minutes from the March 4, 2021 Board meeting.

The motion passed unanimously.

4. Deputy Wisda moved and Mr. Blais seconded the motion to recess from the Regular Session and convene into an Executive Session for agenda item 4 for the purpose of receiving legal advice regarding agenda items according to A.R.S. §38-431.03(A)(1) and (3).

The motion passed unanimously. The Board recessed from Regular Session, entered into Executive Session at 10:37 a.m. and reconvened back into Regular Session at 11:08 a.m.

5. A motion was made by Deputy Wisda and seconded by Mr. Blais to accept the Accidental Disability Retirement application for Deputy Jillian Oshsner. Deputy Ochsner will be sent to an IME; a Board-Certified Orthopedic Surgeon specialized in wrist and hand.

The motion was passed unanimously.

6. A motion was made by Deputy Wisda and seconded by Mr. Blais to send Mr. Jeffrey Cadle to another IME; a Board-Certified Psychiatrist specializing in PTSD. It was requested that Mr. Cadle provide additional medical documents from the VA so that the IME may make a distinction between a MCSO work related condition vs. Military related condition.

The motion was passed unanimously.

7. A motion was made by Deputy Wisda and seconded by Mr. Blais to accept and approve the following entries into the Deferred Retirement Option Plan (DROP):
 - a. Effective 03/15/2021 for Rudy Verdugo Acosta Jr., who will retire and enter DROP in the monthly amount of \$5,427.08.
